- 78 - At Ricky Cox Monument, turn W (away from pedestrian bridge) to continue on the Trinity Trail along the West Fork branch of the Trinity River, restricted to concrete path
- 79 - U-turn at turnaround point to head E on Trinity Trail, restricted to concrete path
- 80 - At Ricky Cox Monument, turn S to continue on the Trinity Trail along the Clear Fork branch of the Trinity River, restricted to concrete path
- 81 - Leave trail to continue S on gravel trail connector toward River Dr cul-de-sac
- 82 - Leave gravel path and continue S on River Dr through cul-de-sac
- 83 - At Cedar Elm Rd, turn SW to continue on River Dr
- 84 - W then N on Trinity Park Dr
- 85 - N on Foch St
- 86 - W on Farmhouse Way
- 87 - S on Trail Dr, right restricted
- 88 - Cross University, continue on Trail Dr, right restricted
